### **1. Scope of Supply:**

1. The tenders shall be submitted as per the technical specifications enclosed in Annexure – I. Please inspect the Calendar 2017 available at the Stores section of NIRT On 17.11.2017 between 11.00 am to 1.00 pm
2. NIRT, Director reserves the right to accept or reject any or all tenders without assigning any reason thereof.

### **2. Bid Submission and Opening:**

- a. The bid should be submitted online at website <http://eprocure.gov.in/eprocure/app> only by due date as in NIRT of the bid. The server date and time as appearing on the website only shall be considered for the cut-off date and time for submission of bids. Offers sent through post, fax, e-mail and courier or by any other mode will not be considered.
- b. Only those bidders shall be considered qualified who submit all the terms and conditions of the tender document. The decision of NIRT shall be final and binding.

### **3. Submission of Bids:**

- a. Only bids received on e-tendering portal will be considered for opening. Bids in any physical form sent through fax/e-mail/courier/post/delivered personally will not be considered.
- b. Bidder will be responsible for any delay due to other issues.

**6. Price:**
