1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.

3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.

5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

6. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

7. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The firm shall carry out proper maintenance of the hardware / software to ensure that all the equipment remains in good working condition.
2. The firm should be system integrator/IT Service Provider having adequate technical capability and experience in managing and providing support for computer hardware, software and peripherals.
3. The firm shall have a minimum of 5 years experience in maintenance of IT equipment and should have successfully executed at least three similar CAMC contracts during the last five years. At least one similar contract should preferably cover 200 or more IT assets. Documentary proof such as work orders and satisfactory performance/completion certificates shall be submitted.
4. The bidder shall possess a valid ISO 9001:2015 certification for Quality Management System issued by an accredited certification body. A copy of the valid certificate shall be submitted along with the bid.
5. Service calls should be attended within 4 hours for Servers and within 24 hours for other equipment. If the call is not completed within 48 hours a suitable standby/replacement shall be provided wherever technically feasible.
6. Periodic Preventive Maintenance shall be carried out once in three months without fail and the firm shall submit the Uptime/Availability report of all peripherals. If the availability of the system or part thereof is continuously below 75% over a period of 3 months, ICMR-NIRT reserves the right to terminate the contract in full without any cost implications.
7. The contract shall cover services, repairs and replacements necessary to keep the equipment in good working condition. It shall cover all the spares in the system & monitors, optical drives, hard disks, SSDs, keyboard, mouse and other components, including plastic/fibre items.
8. The contract shall cover all the spares of laptops including display, battery, charger, adaptors, keyboard, touch display, SSD, HDD, Graphic Card, plastic/fibre body hinges etc.
9. Only printer consumables such as toner and ink cartridges shall be provided by ICMR-NIRT. The contract shall cover all other spares of printers and scanners including printer head, laser fuser assemblies, fuser unit, Teflon sheets, maintenance kit, image kit, scanner lamp, transparency units and plastic/fibre items etc.

10. At least one qualified dedicated Resident Engineer shall be posted at ICMR-NIRT for maintenance and to attend/fix the issues from 9:00 AM to 5:30 PM on all working days.
11. The Resident Engineer shall possess a Degree in Computer Science/IT/Computer Engineering/Electronics or equivalent with minimum 3 years relevant experience OR a Diploma in the above disciplines with minimum 5 years relevant experience in maintenance of IT equipment.
12. The Resident Engineer shall be capable of resolving hardware and software issues that arise from time to time.
13. Background verification shall be carried out for all resident engineers/personnel deployed at ICMR-NIRT and the firm shall submit a declaration to this effect. Before posting the engineer, the firm shall submit his/her CV and qualification/experience certificates for vetting and acceptance by ICMR-NIRT.
14. An alternative qualified Resident Engineer shall be provided in case of absence/leave of the Resident Engineer without interruption of service. The substitute shall possess equal or higher qualification and experience.
15. The firm/contractor shall ensure that all its workmen are covered under applicable statutory provisions, including ESI and EPF, wherever applicable, and shall produce the relevant registration/enrolment details before commencement of the contract.
16. The contractor shall regularly remit the applicable employer and employee contributions under ESI/EPF and comply with all applicable labour laws and statutory requirements.
17. The CAMC period shall start from the date specified in the contract and shall be for a maximum period of one year. The quoted rates shall remain firm throughout the contract period. No additional charges shall be levied by the vendor for services/spares covered under the CAMC.
18. The firm shall provide all necessary tools, testing instruments and equipment to the Resident Engineer for servicing the equipment covered under the contract.
19. ICMR-NIRT reserves the right to increase/decrease the quantity or delete a particular item while placing the purchase order, subject to applicable GeM/Government procurement provisions.
20. Before commencement of the contract, the firm shall inspect all IT equipment at the respective sites and acquaint itself with the local conditions, location, accessibility and other requirements. No additional claim shall be accepted on account of failure to inspect the site.
21. Replacement of faulty items shall be with the same make, model, and capacity/specification wherever available. If the original item is obsolete or unavailable, an equivalent or higher specification item may be provided with prior approval of ICMR-NIRT.

ICMR-NIRT, Madurai Unit (Rajaji Hospital Madurai GH):

22. The firm shall arrange a qualified Service Engineer to attend service breakdown calls at the ICMR-NIRT Madurai Unit.
23. The contact details of the local Service Engineer at Madurai shall be provided at the commencement of the contract. The Service Engineer shall attend service calls within 2 hours at the ICMR-NIRT Madurai site.
24. Preventive Maintenance shall be carried out once in three months at the Madurai site, and a separate Uptime/Availability Report shall be submitted.
25. **Payment:** No advance payment shall be made. Payment shall be released once in every six months, after satisfactory completion of services for the respective six-month period and certification by the designated officer of ICMR-NIRT.
26. **Performance:** Repeated failure to provide the Resident Engineer, failure to comply with service response time, non-performance, poor service, failure to carry out preventive maintenance, or repeated SLA violations may attract proportionate deductions/penalties and further contractual action as per applicable GeM/Government provisions.

Other Terms and Conditions

- i) Bidder should mandatorily submit their **GST Registration Certificate**.
- ii) The bidder shall inspect all the IT equipment, and a **Site Visit Report** on the firm's letterhead, **duly attested by the ICMR-NIRT EDP Department**, shall be uploaded along with the bid documents.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents (other than EMD and signed Integrity Pact - which can be submitted within 5 days of bid opening) in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
