
**INSTRUCTIONS TO THE CANDIDATES:**

Attach self-attested copies of all credentials in support of **educational qualifications, age, caste/community, Aadhar Card.**
3. **For walk-in selection:** Candidates should bring the filled application along with photocopies of all the certificates to Venue: **ICMR-National Institute For Research In Tuberculosis No.1, Mayor Sathyamoorthy Road, Chetpet, Chennai: 600031** on the date and time mentioned above. **Original Certificates of all these credentials should also be carried for verification.**

The last date for receiving online applications in email is **20.01.2026 up to 4.00 p.m.** Eligible/shortlisted candidates will be informed via email to join the online interviews. Selection will be subjected to verification of original certificates which will be scheduled on a later date.
5. Mere fulfilling the essential qualification does not guarantee the selection.
6. For reserved category posts, candidates must produce their latest Caste Validity Certificate. OBC candidates must possess a latest valid non-creamy layer certificate. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
7. Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other ICMR research projects will also be admissible for experienced and skilled persons.
8. Experience certificate should clearly state the nature of work during the period of employment.
9. No-Objection Certificate from the current employer (for Govt./AB/PSU Servants only).
10. All posts are Contractual for the duration offered. The engagement may be renewed after every specific period subject to satisfactory performance and project requirement.
11. The incumbents selected will have no claim for regular appointments under NIRT/ICMR or continuation of his/her services in any other project.
12. TA will not be paid by NIRT for attending the written test/ interview.
