Sealed quotation and superscribed as “**L & T GE Make ABC (LT Air Circuit Breakers)**” must be dropped in the quotation box kept at Administration (Stores) section or can be sent through speed post / courier addressed to The Administrative Officer (Stores), National Institute for Research in Tuberculosis, ICMR, No.1 Mayor Sathyamoorthy road, Chetpet, Chennai-31 so as to reach latest by **25.06.2020 at 3.00 PM**. The quotation will be opened on the next day by 11 AM.
4. No advance payment will be made before executing the contract. The payment will be made on rendering the services in two installments one during first half of the year and the other on completion of one year with satisfactorily report of end users.
5. NIRT, Chennai will not be responsible for any delay or late receipt of quotations and the same will not be considered under any circumstances.

6. No extra payment will be made on account of transportation, handling, loading, unloading, labour charges etc,
7. While submitting the quotations the rate against each work and net amount to be paid, GST etc. should be specified separately.
8. The above items being used for research use a concessional GST @ 5% in terms of Govt. notification no.45/2017 – Central Tax (Rate) r.w.T.N.G.O(MS) No.161:47/2017-integrated Tax (Rate) dated 14.11.2017 would be paid against invoice and a DSIR certificate in this regard would be attached with the purchase order.

A performance Security of 5% of the total AMC cost has to be submitted in the shape of a Demand Draft or Bank Guaranty drawn in the name of Director, NIRT while executing the work if the quoted amount is Rs.1.00 lakh or above which will be with-held till completion of contract and two months beyond warranty period.
10. In case any discrepancy / breach in service contract is noticed during the period of AMC, the loss will be ascertained and recovered subsequently and the firm is likely to be black - listed.
