Scope of Work:

- 1. AC machine filters must be cleaned every month.
- 2. Water wash for AC machine must be done once in three months.
- 3. In case of fault in the AC compressor, the compressor must be replaced instead of repairing the fault one by cut open.
- 4. To rectify the defected AC within 12 hours of reporting the fault (if not possible to repair a stand by AC must be provided).
- 5. Service report card provided by this office must be maintained in each AC unit.
