Mode of Service:

1. Every two months, service representative of service provider will check both ups as per Attached check list.
2. The date of visit will be decided by us. Two days before information will be given to you about the date of visit.
3. Break down & All Repair works, including spares (except Batteries & all Inter connecting & main cables) at free of cost, must be attend with in two Hours from the time of information about issue during working days, in public Holidays & Sundays within 4 hours, by service provider.



4. If we planned to shift UPS from Existing place to another place service provider has to do shifting work at right time and Batteries are given by us. Information for shifting work will be informed one day before.
5. This contract will be considered as invalid if service provider fails to visit the UPS for more than three months or fails to attend break down immediately (within 2 hours, after receiving information) during working days, holidays & Sunday Or else service provider agree to pay down time cost & service cost.
6. Service provider will bring special tools for doing repair works
7. Batteries replacement should be done at free of cost if batteries failed.

Terms & Conditions:

1. The NIRT reserves the right to accept or reject the quotations without assigning any reasons thereof.
2. Any decision taken by the Director, NIRT at any point of time in connection with this process shall be final and conclusive and no claim or dispute from any quarter in this regard shall be entertained. The last date may be extended subject to requirement.
