4. No advance payment will be made before executing the contract. The payment will be made on rendering the services in two installments one during first half of the year and the other on completion of one year with satisfactorily report of end users.

6. In case of circuit Breaker suddenly failure or not functioning, immediately come and attend the fault & rectify the same
